Congratulations to all the winners and sincere thanks to all who participate in our elections.

2) Levy Election---the levy passed with a 63.5% approval. The McCleary decision (which provided ISD with more than \$40 million for us to bargain improved compensation and some workload relief) has reduced our reliance on locally-derived funding, though the levy still comprises about 13% of the overall budget. We can all breathe a sigh of relief that the levy

has passed! It will bring in about \$104 million over the next two years. MANY thanks to those of you who helped send out nearly 13,000 postcards, sported bumper stickers, helped with sign-waving, and talked to your neighbors about the importance of funding our public schools.

- 3) Calendars---At this writing, we have agreement only about the 2020-21 calendar, and the District has published it on their website. The first student day will fall on Tuesday, September 1st, with the first day for kindergarten students on Friday the 4th. This means the first PD day (for IEA members in the special education department) will occur on Monday, August 24, with the subsequent days (the 25th-31st) being five of our seven negotiated non-student per diem days. In December, the District and the Association each sent a team to negotiate potential revisions to the 2020-21 and 2021-22 calendars and we also needed to set the calendar for 2022-23. IEA uses our survey data and member input to determine our priorities, and the District derives its priorities from their own surveys and input gathered from the community. Your bargaining team always strives to represent what the majority of our members tell us matters most to them via our calendar survey. Our membership's priorities have been consistent during each of the past three years, in order of preference--- 1) keeping spring break at one full week; 2) having two full weeks in December (and consequently three weekends); 3) having a week of February break; 4) finding ways to add some make-up days came in as a lower priority for the majority of our members who responded to the survey. Negotiation involves some reasonable compromise from both parties, and we will let you know when we have reached agreement on the 2021-22 and 2022-23 school year calendars. Please thank our calendar bargainers (Carolyn Santos, Cathy Gilbert, Courtney Teddy, and Greg Harrington) who've spent many hours on this important and complicated issue.
- 4) Regional School Board Listening Sessions---the ISD School Board would like time to connect directly with IEA members. This year they have set aside three Wednesday mornings, arranged by High School Feeder Patterns. If you are a middle or high school educator, please consider attending the session that is within your feeder pattern:
